From the North

Take the 405 South to Culver. Exit Culver and make a right. Culver turns into Bonita Canyon Drive. Stay on Bonita Canyon until you reach Turtle Ridge. Make a left on Turtle Ridge and a left on Federation Way. Follow Federation Way to the end and park near the basketball courts. Enter the building through the basketball court gate.

From the South

Take the 405 North to Culver. Exit Culver and make a left. Culver turns into Bonita Canyon Drive. Stay on Bonita Canyon until you reach Turtle Ridge. Make a left on Turtle Ridge and a left on Federation Way. Follow Federation Way to the end and park near the basketball courts. Enter the building through the basketball court gate.

From the North using the Tollway

Take the 405 South to the 73 South. Exit Bonita Canyon (Toll) and turn right on Bonita Canyon. Make a right on Turtle Ridge and a left on Federation Way. Follow Federation Way to the end and park near the basketball courts. Enter the building through the basketball court gate. (*Alternate without tolls is to exit MacArthur and follow until Bonita Canyon/Ford Rd. and turn left until you get to Turtle Ridge.*)

From the South using the Tollway  
Take the 73 north to Bonita Canyon. Exit Bonita Canyon and make a right. When you reach Turtle Ridge, make another right. Make a left on Federation Way. Follow Federation Way to the end and park near the basketball courts. Enter the building through the basketball court gate.

# Weekends

## Accommodations

All cabins have bunk beds and hold up to 13 campers. Each cabin is equipped with heaters, bathrooms, and showers. Each cabin is staffed with at least one senior counselor and one junior counselor. Student bunking requests will be met according to space limitations and timely receipt of RSVP card.

## Shabbat Observance

Since Bureau programs serve Jews from various congregations and we would like to make the greatest number of people feel comfortable, the Bureau Board has established an observance policy with the following guidelines: we have Friday night and Shabbat morning services and Havdalah on Saturday night. We use a guitar in our services. We do not light fires, put out fires, cook, take pictures, write or watch videos on Shabbat.

## Arriving Late or Leaving Early

Teens may only arrive late or leave early from weekends if they have a major family event or are participating in an activity as part of a group where their absence would hurt other members of that group (i.e. team, band, ensemble, etc.). If parents are driving their teen to camp late or picking up early, special arrangements need to be made with the Director prior to the weekend. Campers cannot be picked up from camp and then return at a later time during the weekend.

## RSVP Postcard

We must know at least 10 days in advance of each Adat Noar Weekend whether or not your teen will be attending. Therefore, prior to each Adat Noar minicourse, you will receive an RSVP postcard for the upcoming Adat Noar Weekend. You must return the postcard promptly to ensure a space for your child on the bus and in a cabin. (In case of emergency, of course, you can let us know of a cancellation up until noon on Friday.) Knowledge of who is able to attend is crucial for the planning of meals, all our activities, bunking arrangements, and putting students in program groups. If there is another camper that your student has a significant problem sharing a bunk with, please alert the office.

One of the important goals for students at the start of our weekend experience is their participation in ushering in the Shabbat in an unhurried fashion. Sufficient time is needed for unpacking, creating a Shabbat environment, meeting with counselors and cabin mates, dressing for Shabbat, etc. Given the heavy traffic patterns, the Friday afternoon bus schedule is designed to make this possible. Timely arrival at camp also guarantees that Shabbat services and dinner may be scheduled at reasonable hours.

## Dismissal from School

Should you have difficulty in obtaining early dismissal, you should be aware of the following: California education code #48205 provides for students to leave school for "justifiable personal reasons, including, but not limited to:....Attendance at religious retreats. A child should be allowed to complete all assignments and tests if missed during the excused absence that can be reasonably provided; and upon satisfactory completion, shall be given full credit therefore."

## Ethical Values



## Communications

Prior to the weekends: Please call the Bureau of Jewish Education 949/435-3450 The Bureau office will be open until 3:30 pm on Fridays.

During the weekend: In case of an emergency during an Adat Noar weekend, you may reach the staff at (714) 785-7792 . This is the number of our emergency phone. Also, please do not ask your child to call and check in with you during the weekend.



## Behavioral Standards

The goals for Bureau programs include promoting Jewish friendships and values as well as sharing significant Jewish learning experiences. Therefore, the Bureau insists that all members of the Adat Noar community treat one another with *kavod* (respect) and *hesed* (kindness). Participation in Adat Noar is contingent upon the appropriate and cooperative behavior of each student. Disruptive or inappropriate behavior will lead to dismissal from the program.

## Weather and Dress

**Shabbat:** In order to make Shabbat different from the rest of the week, we insist that everyone must dress in nice clothes for Friday night services. While you do not want to wear your High Holiday best, please remember that jeans, t-shirts, and shorts are not appropriate for Erev Shabbat. While Shabbat itself continues through Havdalah on Saturday night, dress is more relaxed during the day. We also encourage you to bring your own kippah and talit for Shabbat services.

**Other:** At **no time** during camp weekends, should a student wear clothing that would not be deemed modest. This includes spaghetti straps, revealing mid-riffs and pants/skirts that reveal undergarments. All skirts must come to the knees of the camper. Because we will be in the foothills, we ask that you dress warmly in the evenings. Shorts and/or jeans will be suitable for daytime.

## Food

All of the food at Brandeis-Bardin Institute is kosher. The food is very good. In addition to meals, there are plenty of snacks throughout the weekend. For Kashrut and health reasons and for keeping unwanted animals out of the cabins, please do not send food with your child. It will be taken away upon arrival at camp and not returned. If your child has food allergies which need to be taken into consideration while planning camp meals, please contact Robyn Faintich, Director of Youth Education, at least three weeks prior to the weekend.

## CODE OF CONDUCT & DRESS CODE

Disciplinary Policy for all Bureau Youth Programs

**These guidelines apply to all Sunday Sessions, Volunteer Programs and Weekend Retreats**

In order to ensure the safety and well-being of all our students, the staff of the Bureau will enforce the following policies:

1. Any student who is deemed to be a danger to him/herself, to others or to the program will not be permitted to participate in Bureau activities.
2. Possession of any illegal or unlawful item will result in immediate dismissal from the program. These items include: cigarettes, alcohol, drugs, and weapons.
3. On weekend camp retreats, students will also be dismissed from the program for entering a cabin of the opposite sex at any time. Students may also be dismissed for leaving their cabin after "lights out" or for indecent exposure.
4. If a disciplinary action has been taken against a student in school, camp or the community, the students' parent is required to schedule a consultation with the director in order for the student to enroll or to continue (if it occurs mid-year) in a Bureau program.
5. If a student has been diagnosed with a medical or psychological problem that could result in his/her being a danger to him/herself, others or the Program, the director must approve his/her participation and may require certain conditions (i.e. doctor's note, on-going therapy, etc.)
6. If the Bureau learns of an undisclosed disciplinary action or problem diagnosis, the student will immediately be dismissed from all Bureau programs. Immediate dismissal means that a parent will be called to pick up the student immediately, regardless of the time of day or the location of the program.

**Dress code:**

Our community upholds respect and honor to each individual. In order to maintain this standard, please do not plan to wear any item that is strapless, or reveals your midriff or undergarments. In an effort to uphold the Bureau values, no garment should display graphics of drugs, alcohol, profanity or violent acts. If a program participant chooses to wear a skirt, it must come at least to the knees.
